Victoria (B.C.), February 21, 2017 – The aerospace industry's important contributions to British Columbian jobs and economic prosperity were once again recognized in today's provincial budget, announced by Finance Minister Mike de Jong. Budget 2017 continues the government's 5-year, \$5 million commitment to develop and grow the aerospace industry in BC. Through this investment, AIAC Pacific will continue to work with government and other partners to build a unified and sustainable aerospace cluster in B.C. that creates highvalue employment and innovative, export-intensive companies.

AIAC Pacific also noted several other Budget 2017 measures that will promote growth in our sector:

- Reducing the small business corporate income tax rate
- Reducing the tax rate on electricity effective Oct. 1, 2017 with a full exemption effective Apr. 1, 2019
- Three new government trade and investment offices in ASEAN countries

"Budget 2017 enables AIAC Pacific to continue its work growing and developing the burgeoning aerospace cluster in BC. It also provides measures that will promote growth and competitiveness by focusing on the growing Asia Pacific region. The aerospace industry is an important creator of highly-skilled jobs for British Columbians, and the measures included in today's budget ensures that the government's aim of promoting a competitive, job-creating economy are realized in the aerospace sector," said AIAC President & CEO Jim Quick. "We thank the government for their ongoing commitment to this important sector, and we look forward to continuing our partnership going forward."
